- All vendor products/services must meet at least one of the following criteria:
 - Homemade/Handcrafted Items
 - Items sold through a Home-Based Business
- Products/Services may be sold at this event.
- Harrisonville Parks & Recreation reserves the right to deny a vendor application based on the similarity
 of products with another vendor. All vendor applications are on a First-Come, First-Serve basis only.
 The Spring Craft Show is limited to 24 Vendors Only.
- Each vendor booth will consist of one 8'x4' rectangular table and a chair located in the **Jefferson Courtyard Room.**
- Each Booth space will be an approximate 10'x10' square area. We ask that vendors stay within that respected size of area.
- Vendors may begin to arrive for set up no earlier than 7am on the morning of the event.
- Booths are required to be ready by 9:45am. Vendors will be expected to stay for the entire event; event will be advertised to the public from (10am to 4pm).
- Cancellation/No Show Policy: If for any reason you are unable to attend the event, please contact
 Amy Fuller at 816-380-8980, ext. 5999 as soon as possible. Refunds will only be given if we are able to
 fill your booth space. Failure to show up for your booth on the day of the event without notification may
 disqualify you from future events and no refunds will be granted.
- Electrical Outlet use is only guaranteed for vendors that register and pay for an electric booth. Be sure
 to mark on your application if electricity is needed. Vendors will be required to supply their own
 extension cord (12' cord or longer is suggested)
- Vendor Booth location will be assigned by the Events Coordinator: Vendors may request a booth against a wall, a booth in the middle, or no preference. Requests are on a first-come, first serve basis.
 Booth Location Requests are NOT guaranteed.

Cost to reserve a booth space will be \$45 for non-electric OR \$50 for electrical access. To reserve your booth space, please submit your completed vendor application to the Harrisonville Community Center either in person, email, fax (816.380.8987) or by mail. Application must be received no later than the registration date. Booth space is limited to 24 vendors and is reserved on first-come, first-serve basis only. Once your application has been received you will be notified regarding whether or not your application has been approved; if your application has been approved then payment in full will be required.
